



Pricing and Payment Policy (updated 1-3-2012)

Mission Statement

Our philosophy at Body Solution Systems, LLC is to combine both allopathic medicine and natural remedies to create optimal health for our patients. Traditionally, physicians are educated on how to treat, not prevent disease. Our physician's goal is to help you prevent disease before it occurs and increase longevity of life by conducting comprehensive laboratory studies to determine your current health status, and then formulate a comprehensive treatment plan specifically for your needs.

The acceptance of preventative health care is growing daily in the United States, but unfortunately, many insurance companies are slow in understanding the benefits of preventative health, and are hesitant to reimburse for these services. Therefore, Body Solution Systems, LLC has established guidelines for payments of medical services rendered. The following information is provided to help you understand the policies we have established. It is our wish to provide you with the finest level of care. We hope that insurance companies will one day view preventive medicine as a covered medical service versus an elective therapy.

Fees for Standard Professional Services

The fee for your initial consultation and medical evaluation is \$495.00. During this initial consultation, we will be thoroughly discussing your complete medical history, your immediate health concerns, and your long term health care goals. Based on your lab results we will develop a comprehensive treatment plan to obtain optimal health results for you.

You will then be required to meet with the doctor on a weekly or bi-monthly basis for the first 4 to 6 weeks. Each office visit with the Doctor will cost \$45.00. Required visits after the first 4 to 6 weeks will be determined on an individual basis depending on the severity of health issues.

Other costs associated with the program include meal replacements which average \$16.00 per day (or \$112.00 per week) and anti-oxidant supplementation which runs approximately \$25-\$35 per week.

Additional costs may include various injections which are \$35.00 each and additional prescription medications.

Standard Payment Policy

All patients are responsible for payment in full (100%) at the time service is rendered. We accept MasterCard, VISA, Discover, personal checks and cash for payment of services.

Fees for Alternative/Specialty Treatments

Some of our treatments may be "billable" to insurance companies, but are still considered, "alternative", and may not be covered under certain policies. We are happy to provide you with a "super bill" that you may forward to your insurance company, however, we cannot guarantee that your insurance company will reimburse you.

Medicare/Medicaid

Body Solution Systems, LLC is not a part of the Medicare/Medicaid system.

Patients who are eligible for Medicare/Medicaid benefits cannot receive reimbursement from Medicare/Medicaid for any services provide by Body Solutions Systems, LLC. Secondary insurance will not consider review of claims, which have not been recognized by Medicare/Medicaid. Medicare/Medicaid patients are required to sign a letter of understanding in regard to services provided by Body Solution Systems, LLC at the time of initial visit, indicating their knowledge of this policy and are not to attempt to obtain reimbursement from Medicare/Medicaid. 100% payment is required at the time of service for all patients.
